INVITATION TO BID FOR THE SALE THROUGH PUBLIC AUCTION OF ONE (1) UNIT VEHICLE

1. The Bulacan Water District, through its Bids and Awards Committee (BAC) , hereby announces the sale through PUBLIC AUCTION its vehicle which was found unserviceable and obsolete beyond economic repair described in Annex “A” and “B”.
2. Based on the Agency In-House/Third Party Appraisal Report and Appraisal Review Report on Property for DISPOSAL of COA, Region III, the starting bid price of the one (1) unit of vehicle described above is **One Hundred Thousand Pesos (₱100,000.00)**.
3. The mode of disposal is PUBLIC AUCTION “as is where is” except for the battery (for testing only). The winning bidder can withdraw the item at the BWD Office Bldg., Calle Estacion cor. Molina St., San Jose, Bulakan, Bulacan from 8:00 a.m. to 5:00 p.m., Monday to Friday.
4. The BAC requires submission of buyers’ Technical Requirements which includes Latest Financial Statement (for Company) with a net worth of equal to or more than the floor price, latest Income Tax Return (ITR) (for Individual), and Affidavit of Disclosure of no Relationship.
